VARIOUS ENGINEERING AND RELATED SERVICES

The **South Dakota Department of Transportation (SDDOT)** is soliciting statements of interest and qualifications from consulting firms for both State and Local Government projects. The purpose is to select a list of consultants, in each category of work, for which the SDDOT will enter into a Pre-Qualified Consultant Retainer Agreement for the years of **2017 - 2019**. The SDDOT will determine the number of firms selected in each category of work based on the anticipated workload and the qualifications of the firms submitting Standard Form 925. The number following each category represents the anticipated numbers of firms to be accepted for that category. The categories of services include the following:
